SECTION 4: FIRST AID MEASURES

4.1. Description of first aid measures

Inhalation

In case of inhalation of spray mist: Move person into fresh air and keep at rest. Get medical attention if any discomfort continues. If breathing stops, provide artificial respiration. Get medical attention immediately!

Ingestion

Protective equipment

Impermeable gloves and safety glasses

Process conditions

Provide eyewash station.

Engineering measures

Provide adequate ventilation. Observe occupational exposure limits and minimize the risk of inhalation of spray.

Respiratory equipment

No specific recommendation made, but respiratory protection must be used if the general level exceeds the recommended occupational exposure limit.

Hand protection

Use suitable protective gloves if risk of skin contact. The most suitable glove must be chosen in consultation with the gloves supplier, who can inform about the breakthrough time of the glove material. Nitrile gloves are recommended, but be aware that the liquid may penetrate the gloves. Frequent change is advisable.

Eye protection

If risk of splashing, wear safety goggles or face shield.
